Late received tenders will be rejected and returned unopened to bidder.
- Interested bidders are advised to visit the site for physical inspection before submitting the bid.
- Bidders must ensure that all the required documents indicated in the bidding documents are submitted with the bid without fail, incomplete bids or bids received without undertakings, valid documentary evidences, supporting documents or not sealed, signed or stamped, or received late will be rejected.
- Income/Sales Tax registration certificate and other documents as mentioned in bidding documents must accompany bids. Taxes will be deducted as per government Rules.
- The Bid Security at the rate of 2% of the quoted value in the shape of call deposit or a bank guarantee issued by a scheduled bank in the name of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) must accompany with the bid documents.
- Single stage two envelope procedure of open competitive Bidding will be followed.
